#### ARTICLES OF INCORPORATION

OF

# HARD DRIVE CAFE, INC.

WE, the undersigned, being of full age, do hereby agree to become a corporation for profit under the provisions of Chapter 607 of the Florida Statutes, and do hereby accept all the rights, privileges, benefits, and obligations conferred and imposed by said law on corporations organized pursuant to the provisions thereof and hereby make, subscribe, certify, acknowledge, and file, these Articles of Incorporation as follows:

# ARTICLE I

#### NAME

The name of the corporation shall be HARD DRIVE CAFE, INC., a Florida Corporation.

# ARTICLE II

# NATURE OF BUSINESS

The nature of the business and the objects and purposes to be transacted, promoted and carried on are to do any or all of the things herein mentioned.

- 1. Run a Internet access business, computer service/parts and cafe.
- 2. To acquire by lease, purchase, gifts, devise, contract, concession or otherwise, and to hold, own, develop, explore,

improve, operate, lease, enjoy, control, manage, or otherwise turn to account, mortgage, grant, sell, exchange, convey or otherwise dispose of, wherever situated, within or without the State of Florida, any and all real estate, lands, options, concessions, grants, lands, patents, franchise, rights, privileges, easements, tenements, estates, hereditaments, interests , and properties of every kind, nature and description whatsoever.

- To manufacture, purchase or otherwise acquire, hold, own, sell, assign, transfer, lease, exchange, invest in, mortgage, pledge, or otherwise encumber or dispose of and generally deal and trade in and with, both within and without the State of Florida, and in any part of the world, goods, wares, merchandise and property of every kind, nature and description.
- 4. To enter into, make and perform contracts of every kind and description with any person, firm, association, or corporation, municipality, body politic, country, territory, state, government, or colony, or dependency thereof.
- 5.
