The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is TANYA ARTINIAN ANTIQUES, INC.

PURPOSE

This corporation is organized for the purpose of aquisition and sales of antiques, and all other related activities as permitted under the laws of the State of Florida and the United States of America.

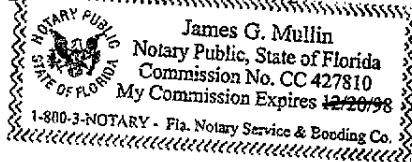
