ARTICLES OF INCORPORATION

OF

S JAN 25 AND The undersigned Incorporator, for the purpose of forming a corporation under the Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: The name of the corporation is CARBONDALE SUPPLY COMPANY.

ARTICLE II: The corporation shall have perpetual existence.
