ARTICLES OF INCORPORATION

OF

SUN LINK PROMOTIONS, INC.

The undersigned, desiring to form a corporation under Chapter 607, the Florida General Corporation Act, does hereby certify:

Article 1 - Name

The name of this corporation (which is hereinafter called the "Corporation") shall be:

SUN LINK PROMOTIONS, INC.

and the principal place of business will be 473 DeFuniak Street, Santa Rosa Beach, Florida 32459.

Article 2 - Commencement and Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

Article 3 - Purpose

The purpose or purposes for which the Corporation is formed are for the purpose of consulting services and engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States of America.

Article 4 - Capital Stock

The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock with a par value of One Dollar per share.

ARTICLE 5 - Preemptive Rights

Every shareholder, upon the sale for cash by this corporation of any shares of new capital stock of the same kind, class, or series, as that which the shareholder already holds, shall have the preemptive right to purchase a pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

Article 6 - Initial Board of Directors

The Board of Directors of the Corporation shall conduct the affairs of the Corporation and shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the shareholders in accordance with the Bylaws of the Corporation. Article 7 - Indemnification

This corporation shall indemnify any officer, director, employee, or agent, and any former officer, director, employee, or agent to the full extent permitted by the law.

Article 8 - Registered Agent

The street address of the initial registered office of the Corporation is 473 DeFuniak Street, Santa Rosa Beach, Florida 32459, and the name of the initial registered agent of the corporation at that address is Malcolm L. Patterson.

Article 9 - Incorporator

Article 10 - Amendment

These Articles of Incorporation may be amended in the manner provided by law. eligible to vote may sign a written statement manifesting their intention that an amendment to the Articles of Incorporation be adopted.

Pursuant to Subsection 607.0901(5), Florida Statutes, the Affiliated Transactions provision contained in Section 607.0901, Florida Statutes, shall not apply nor have any application to this corporation.
