

ARTICLES OF INCORPORATION OF  
BRITT'S TRUCKING, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be BRITT'S TRUCKING, INC.

The principal address of the corporation at the time of incorporation is 1060 N.W. 49th Court, Pompano Beach, Florida 33064.

ARTICLE II. DURATION

The duration of this corporation is perpetual, unless dissolved according to law.


