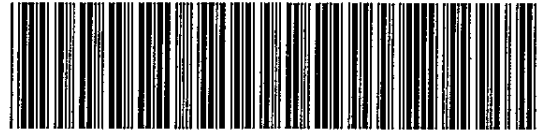

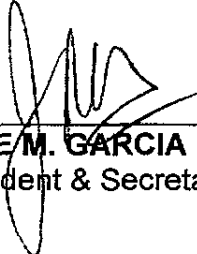
ARTICLE TWO
