OF

INITIAL REGISTERED OFFICE AND AGENT





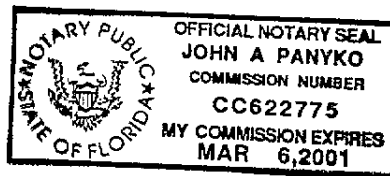
