The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE

Name

The name of the corporation shall be: **KIM C. WEEKLEY AGENCY, INC.**

ARTICLE TWO

Principal Place of Business

The principal place of business and mailing address of the corporation shall be **9965 Glades Road, Boca Raton, Florida 33434.**

ARTICLE THREE

Capital Stock

The number of shares of stock that this corporation is authorized to have outstanding at any one time is One Hundred with a par value of One Dollar (\$1.00) per share.

ARTICLE FOUR

Initial Registered Agent

ARTICLE FIVE

Incorporators

ARTICLE SIXNotice

Any notice required under these Articles, the Corporation's Bylaws or the law of the State of Florida or of the United States, unless otherwise prohibited by law, may be written or oral and delivered in person or by mail, delivery service, telephone, facsimile or other electronic device.

ARTICLE SEVENDirectors and Officers

The initial Directors and Officers of the corporation shall be **KIM C. WEEKLEY**, as **President/Treasurer**.

ARTICLE EIGHTIndemnification

The Corporation shall indemnify, or advance expenses to, so far as is authorized or permitted by law, any person made, or threatened to be made a party to any action, suit or proceeding by reason of the fact that he or she: (1) is or was a director of the Corporation; (2) is or was an officer of the Corporation, provided that he or she is or was at the time a director of the Corporation; or (3) is or was serving at the request of the Corporation as a director, officer, agent or employee of another corporation, partnership, joint venture, trust or other enterprise, provided that he or she is or was at the time a director of the Corporation.

Further, except for those persons entitled to indemnification pursuant to this Article, the Board of Directors of the Corporation shall have, unless otherwise expressly prohibited by law, the sole and exclusive discretion, on such terms and conditions as it shall determine, to indemnify, or advance expenses to, any person made or threatened to be made, a party to any action, suit or proceeding by reason of the fact that he or she is or was an officer, employee or agent of the Corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise.

Further, except for those persons entitled to indemnification pursuant to this Article, the Corporation shall not be authorized nor empowered to indemnify or advance expenses to any other person whatsoever.


