**ARTICLE III SHARES**

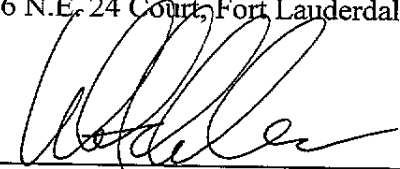
The number of shares that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) common shares with a par value of One Cent (\$.01) for each share.

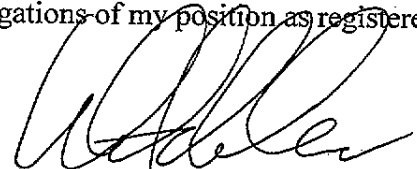
