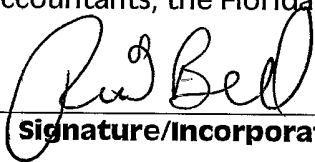

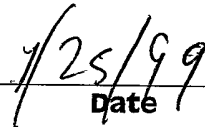

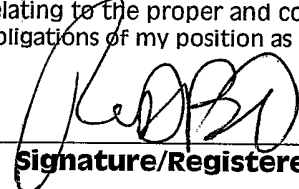
**ARTICLE VI PURPOSE**

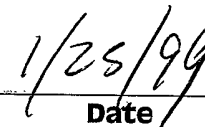
