# ARTICLES OF INCORPORATION

# ARTICLE I - NAME

The name of this corporation is Webs America, Inc.

# ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
