ARTICLES OF INCORPORATION
OF
AFFORDABLE PROPANE INC.

ARTICLE I - NAME

The name of this corporation is AFFORDABLE PROPANE INC.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of signing.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of no par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his/her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL PRINCIPAL OFFICE AND
RESIDENT AGENT

The principal office address of this corporation is 106 Spencer Lane, Lady Lake FL 32159, and the mailing address is 101 Carolina Ave, Lady Lake FL 32159. The principal office and registered office addresses are the same as above. The initial registered agent of this corporation at that address is Brian Butz.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the by-laws, but shall never be less than one (1). ARTICLE VIII - INCORPORATOR

ARTICLE IX - POWERS

This corporation shall have the powers as enumerated in the Florida General Corporation Act.


ARTICLE X - INDEMNIFICATION

No officer, director, stockholder, employee or agent shall be held personally liable when acting in official capacity on company business.
