# ARTICLES OF INCORPORATION

TALLAHASSEE, FLORIDA Articles of. hereby declares these undersigned, The Incorporation for the purpose of becoming a corporation for profit under the laws of the State of Florida.

# ARTICLE I

The name and principal place of business and mailing address of the corporation is:

#### ARTICLE II

The corporate purposes are:

- To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida including, but not limited to, construction consulting services and any activities in any way related thereto.
- To have, in furtherance of the corporate purposes, all of (b) the powers conferred upon the corporations organized in the State of Florida, subject to any limitations thereof contained in these Articles of Incorporation, in Chapter 607 of the Florida Statutes, or any laws of the State of Florida, and to conduct any lawful business or enterprise.

#### ARTICLE III

The Corporation shall have power:

- (g) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships or individuals, or direct or indirect obligations, of the United States or of any other municipality or of any instrumentality thereof.
- (h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any

of its property, franchises, and income.

- (i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
