The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**Article 1: Name.** The name of the Corporation is REMARKABLE, INC..

**Article 2: Duration.** The duration of the Corporation is perpetual.

**Article 3: Purpose.** The specific and general purposes for which the Corporation is organized are the following:

A. The specific purpose for which this corporation is organized is to assist and support the harmonious performance assemblage of the title "No Comment". In addition this corporation may engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article 4: Capital Stock.** The aggregate number of shares which the Corporation is authorized to issue is 1000 (One Thousand) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (One Dollar) per share.

**Article 5: Principal Office, Initial Registered Office and Agent.** The street address of the principal office and initial registered office of the Corporation is 7130 Saddle Creek Circle, Sarasota, FL 34241 and the name of the initial Registered Agent at that address is Robert E. Rainbow.

**Article 6: Initial Board of Directors.** The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased from time to time in accordance with the bylaws but shall never be less than 1 (One). The name and address of the initial director of the corporation is as follows: Robert E. Rainbow, 7130 Saddle Creek Circle, Sarasota, FL 34241.

**Article 7: Incorporator.** The name and address of the incorporator is Robert E. Rainbow, 2012 Whitfield Park Dr. Suite B-23, Sarasota, FL 34243.

**Article 8: Amendment.** The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, any right conferred upon the shareholders is subject to the reservation.

**Article 9: Indemnification.** The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

**Article 10: Bylaws.** The power to adopt, amend and repeal Bylaws shall be vested in the Board of Directors, but all alterations, amendments and repeals of the Bylaws must be approved by a majority of the Shareholders.

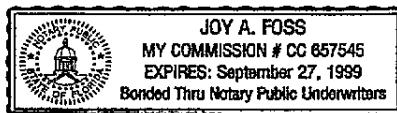

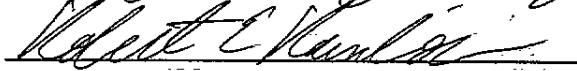
**CERTIFICATE OF DESIGNATION OF
