ARTICLES OF INCORPORATION

Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is Gerald K. Schwartz, P.A. (the "Corporation").

2. The principal office of the Corporation is 1688 Meridien Avenue, Sixth Floor, Miami Beach, Florida 33139.

3. The aggregate number of shares which the Corporation is authorized to issue is 500 shares of Common Stock, par value \$1.00 per share.

4. The street address of the initial registered office of this Corporation is 1688 Meridien Avenue, Sixth Floor, Miami Beach, Florida 33139, and the name of the initial registered agent of this Corporation at that address is Gerald K. Schwartz.

9. The purpose of the corporation shall be for the practice of law.

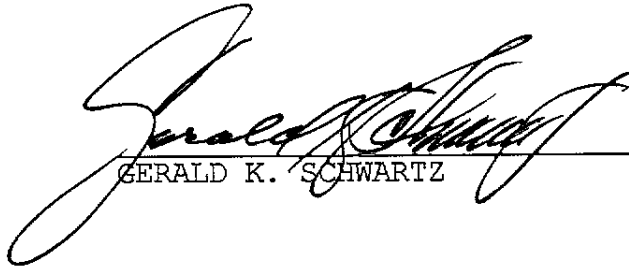
