

# ARTICLES OF INCORPORATION OF ANITRA D. LANCZI, P. A.

THE UNDERSIGNED, FOR PURPOSES OF FORMING A PROFESSIONAL SERVICE CORPORATION UNDER THE FLORIDA PROFESSIONAL SERVICE CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

#### **ARTICLE I - NAME**

The name of the Corporation is: Anitra D. Lanczi, P. A.

#### ARTICLE II - PERIOD OF DURATION

This corporation shall have perpetual existence commencing on the date of execution of these articles.

## ARTICLE III - PURPOSE

This Corporation is organized for the purpose of the practice of law.

### ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the Corporation is authorized to issue is 50,000 shares, all of which shall be common shares with par value of \$.01. Only attorneys licensed to practice law in the State of Florida may be shareholders.

Each shareholder of stock of this Corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the Corporation and any securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.

## ARTICLE VII - INITIAL BOARD OF DIRECTORS
