ARTICLES OF INCORPORATION
OF
HELPING HANDS AROUND THE WORLD, INC.

ARTICLE ONE

The name of the corporation is **HELPING HANDS AROUND THE WORLD, INC.** The principal address of the corporation is: 1300 SOUTH BROADWAY, SUITE 25, LANTANA, FLORIDA 33462 .

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**
