ARTICLES OF INCORPORATION OF LAW OFFICE OF JOHN C. MIOTKE, P.A.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is Law Office of John C. Miotke, P.A.

ARTICLE II: PRINCIPAL OFFICE ADDRESS

The principal office of the corporation shall be located at 550 N. Reo Street, Suite 300, Tampa, Florida 33609.

ARTICLE III: EXISTENCE
