

OF LONG & PERKINS, P.A.

The undersigned, acting as the sole shareholder and director of **Long & Perkins, P.A.**, does hereby file the following amendments to the articles of incorporation of **Long & Perkins, P.A.** dated January 25, 1999:

Article I - Name of Corporation
