OF

ARTICLE I

NAME

The name of this corporation is MIKE'S PLACE, INC.

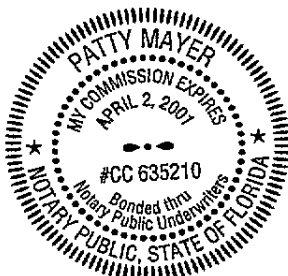


