



ESRC, INC.

The undersigned, desiring to form a corporation for the purposes hereinafter stated under and pursuant to the laws of the State of Florida, does hereby declare as follows:

ARTICLE I. NAME

The name of the corporation shall be ESRC, INC.

ARTICLE II. BUSINESS AND PURPOSE
