ARTICLES OF INCORPORATION
OF
WHATEVER BY PAM COGBILL, INC.

The undersigned subscribers, Pam Cogbill, competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

The name of the proposed corporation is: Whatever By Pam Cogbill, Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States of America and the state of Florida.

ARTICLE III

The total number of shares of stock which the corporation shall have authority to issue is 100 shares at a par value of \$1.00 per share.

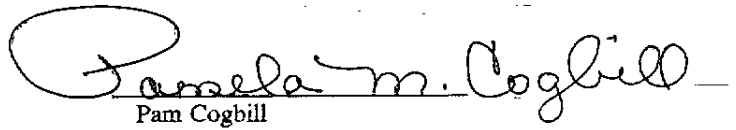

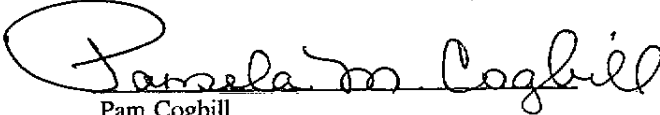
