We the undersigned, being natural persons of legal age, do hereby desire to form a corporation under the laws of the State of Florida, and do hereby adopt these following Articles of Incorporations.

ARTICLE I NAME

The name of the corporation shall be DNA Exterminators, Inc.

ARTICLE II OFFICE & ADDRESS

The principal office of the corporation and its mailing address shall be 2911 Antique Oak Circle No. 12, Winter Park, Florida 32792, in Orange County. These may be changed from time to time by the Board of Directors.

ARTICLE III STOCK

The maximum number of shares of stock of the corporation authorized to be outstanding at any one time is Two Hundred (200) Shares of common stock having a par value of \$25.00 per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors of the corporation.

ARTICLE IV OFFICE & AGENT

ARTICLE V DIRECTORS

The corporation's business shall be conducted and managed by a Board of Directors consisting of not less than two members, as fixed from time to time by the By-Laws of the corporation. The Directors shall be elected or appointed as provided in the By-Laws.

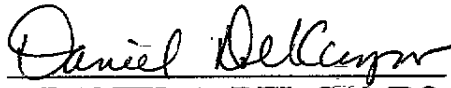
