ARTICLES OF INCORPORATION
OF

I

The Name of the corporation shall be PAISANO, INC.

The duration of the corporation shall be perpetual.

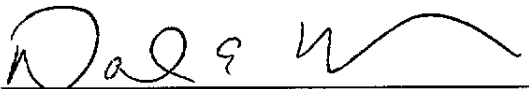
