The name of the corporation shall be:

ARTICLE II - DURATION


ARTICLE X - INDEMNIFICATION

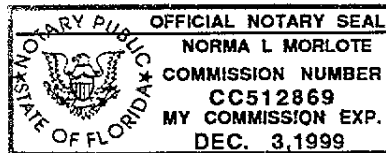
