

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **D & E Glass, Inc.** The principal place of business of this corporation shall be 1501 Sparrow Street, Longwood, FL 32750.

Article II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, or country.

Article III

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.

Article IV

The street address of the initial registered office shall be 1501 Sparrow Street, Longwood, FL 32750 and the name of the initial registered agent of the corporation at that address is Donna Y. Hill.

Article V

The corporation is to exist perpetually.

Article VI

This corporation shall have two (2) Directors initially. The number of Directors may be either increased or diminished from time to time as permitted by the By-Laws, but shall never be less than one (1). The name and addresses of the Initial Directors are: Donna Y. Hill and Edward E. Koster, both at 1501 Sparrow Street, Longwood, Fl 32750.

Article VII

The initial officers of the corporation are as follows: Edward E. Koster, President and Donna Y. Hill, Secretary and Treasurer, both at 1501 Sparrow Street, Longwood, Fl 32750.

Article VIII

The name and street address of the subscriber of these Articles of Incorporation is: Donna Y. Hill, 1501 Sparrow Street, Longwood, Fl 32750.

Article IX

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

Article X

This corporation reserves the right to amend or repeal any provision contained in these Articles, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

Article XI

This By-Laws of the corporation may be amended by majority vote of either the directors or the shareholders.

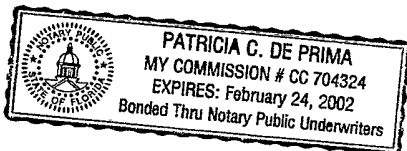
