**ARTICLE I - NAME**

The name of this corporation is **EAST - WEST CONSULTANTS, INC.**

**ARTICLE II - DURATION**

This corporation shall exist perpetually.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of temporary and permanent placement service, and for any other lawful purposes.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 700 shares of \$10.00 per value common stock.

**ARTICLE V - ADDRESS OF PRINCIPLE OFFICE**

The initial post office address of the principle office of this corporation shall be **Suite 302, 779 E. Merritt Island Causeway, Merritt Island, Florida, 32952-3309.**
