ARTICLES OF INCORPORATION

<u>OF</u>

BY THESE ARTICLES OF INCORPORATION, the incorporator for a corporation for profit under Florida law.

NAME

The name of this corporation is MYSTIKAL SOL, INC.

ADDRESS

TERM

This corporation shall exist perpetually.

PURPOSE

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Florida law.

STOCK

The corporation is authorized to issue 10,000 shares of common stock with \$1.00 par value. The stockholders may dispose of the authorized and unissued stock from time to time. 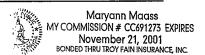
