ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose forming a corporation under the Business Corporation Act, hereby adopts the following Articles of incorporation.

ARTICLE I

The name of this corporation shall be HAVANA NORTH, CORPORATION, INC.

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purpose of this corporation is the manufacture and wholesale and retail sales of clothing and related articles; and all other related purposes not prohibited by law.
