

ARTICLES OF INCORPORATION OF ROBYN M. WEISS, CPA, P.A.

The Undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

- 1. The name of the corporation is as follows: **ROBYN M. WEISS, CPA, P.A.**
- 2. The period of its duration is perpetual.
