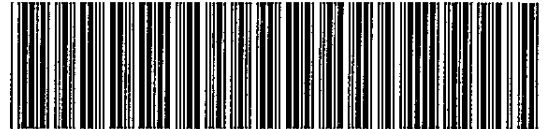



Pursuant to Section 607.1006, Florida Statutes, Motes, Carr, Shaw, Sears, Sturgess & Williams, P.A. hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:
