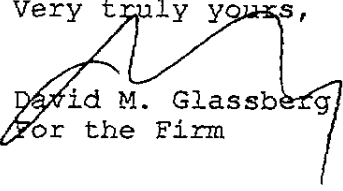

The name of this organization shall be:

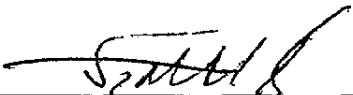
