ARTICLES OF INCORPORATION OF EADS MILLWORKS, INC.

EFFECTIVE DATE

The undersigned, for the purposes of forming a corporation under the Florida general Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE ONE NAME

The name of the corporation is Eads Millworks, Inc.

ARTICLE TWO DURATION

This corporation shall commence existence as of the date of execution of these articles. The term of existence shall be perpetual.

ARTICLE THREE PURPOSE
