This corporation shall have one (1) director initially: James Roscoe Jr. 511 SW 31 Avenue Fort Lauderdale, Fl 33312.

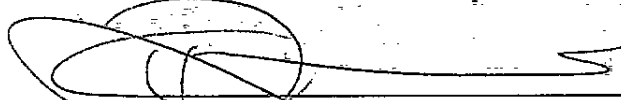

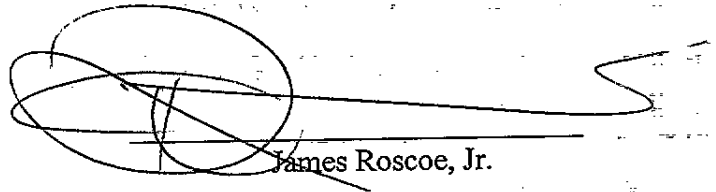

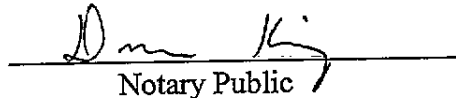
