WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST:** The name of the corporation is N & M INTERNATIONAL ENTERPRISES, INC.
- SECOND:** The period of its duration is Perpetual.
- THIRD:** The purpose(s) for which the corporation is organized are import, export, retail electronics, land development, construction and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.





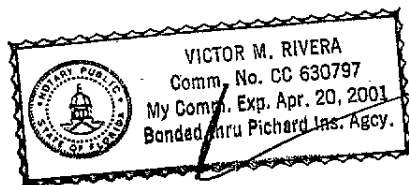
