The undersigned subscriber to these articles of incorporation, being duly licensed to practice medicine under the laws of the state of Florida, adopt these articles to form a corporation under the Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and other laws of the state of Florida.

ARTICLE I – NAME

The name of the professional service corporation is **SAMUEL SNYDER, D.O., P.A..**

ARTICLE II – PRINCIPAL OFFICE

The principal office and mailing address of this corporation 19044 NE 29th Avenue, Aventura, Florida 33180.

ARTICLE III – PURPOSE

The professional service corporation is formed to engage in every phase and aspect of the practice of medicine. 




