The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Article of Incorporation for such corporation:

**ARTICLE 1**


**ARTICLE 1X**

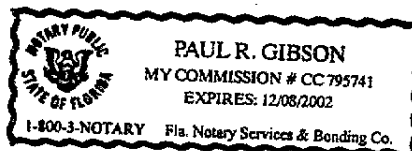
