ARTICLES OF INCORPORATION

OF

KITCHEN KONSIGNMENT, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby intends to form a corporation under the Laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

KITCHEN KONSIGNMENT, INC

ARTICLE II

The general nature of the business to be transacted by this corporation is:

To have and to excerise all the powers now or hereafter conferred by the Laws of the State of Florida upon Corporations organized pursuant to the Laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto, and to engage in any other lawful activities.

To conduct business in, have one or more offices in, and to buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property including franchises, patents, copywrites, trademarks, mortgages and licenses in the State of Florida, and in all other states and countries.
