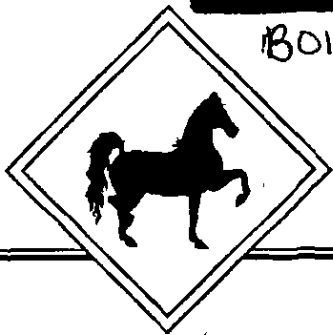
This report is not a tax return, but a state license report.
