**ARTICLE I

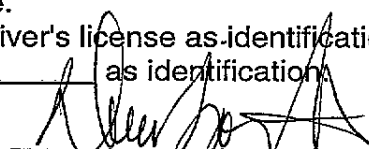

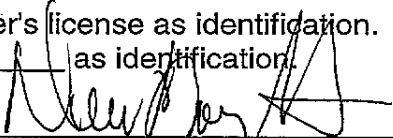
