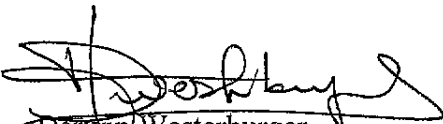

**ARTICLES OF INCORPORATION  
OF

**ARTICLE V - ADDRESS OF PRINCIPAL OFFICE**

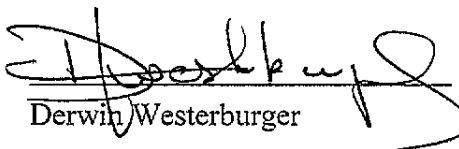

The powers of the incorporator cease upon filing of the Articles of Incorporation.

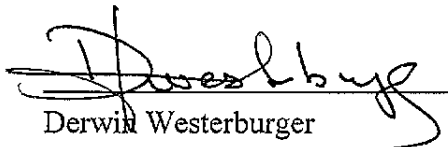
**ARTICLE XI -

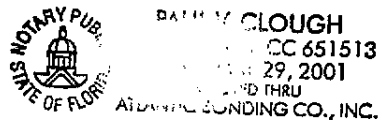
