ARTICLE I - NAME

This corporation shall have perpetual existence commencing on February 01, 1999 and
acknowledgment of these Articles or until such time as it shall be dissolved by law.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting wholesale sales and all business not

ARTICLE IX - BY-LAWS


