The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

EFFECTIVE DATE

ARTICLE I (Name)

The name of the corporation is Robin Hawkins, Inc.

ARTICLE II (Principal Office)
