Articles of Incorporation *of* **JF MACHINE SERVICES, INC.**

Article I - Name

The name of the corporation is: JF Machine Services, Inc.

Article II - Duration

This corporation shall exist perpetually.


Article IX - Initial Officers



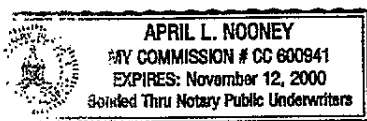


