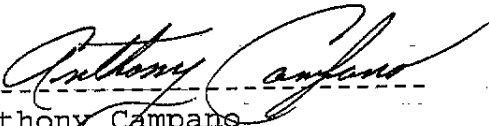
**ARTICLE VI - DIRECTORS**

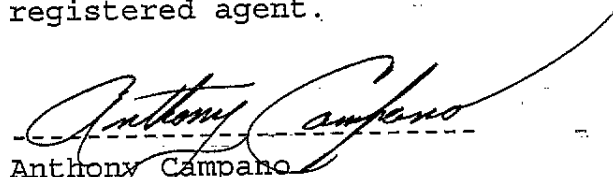
