a natural person competent to contract, hereby forms a corporation
under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful

ARTICLE III. CAPITAL STOCK

authorized to have outstanding at any one time is 1,500 shares of common

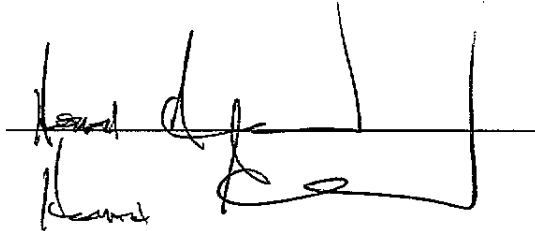

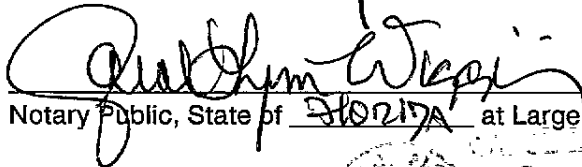
