ARTICLE I-Name

The name of this corporation is Thomas E. James General Contractor, Inc., II

ARTICLE II- Principal Office

The address of the principal office is 919 S. E. Lakeview Dr., Sebring, Florida 33870.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

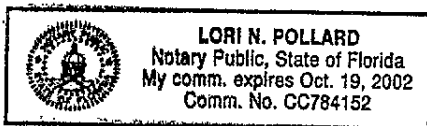
