ARTICLES OF INCORPORATION OF RADIOLOGY ASSOCIATES OF BRANDON, INC.

THE UNDERSIGNED, acting as sole incorporator of RADIOLOGY ASSOCIATES OF BRANDON, INC. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I Name

The name of the Corporation is:

ARTICLE II Business and Activities

The Corporation may, and it is authorized to, engage in any activity or business permitted under the laws of the United States and the State of Florida.
