ARTICLE OF INCORPORATION OF P. T.C. CARGO, INC.

The undersigned subscribers to these Articles of Incorporation is an natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1- NAME

The Name of the Corporation is P.T.C. CARGO INC. (hereinafter, "Corporation").

ARTICLE 2- PURPOSE OF CORPORATION

- 7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any unissued stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

ARTICLE 8- POWERS OF CORPORATION
