# ARTICLES OF INCORPORATION

## ARTICLE I NAME

The name of the Corporation is: ASPHALT REMEDIES ENTERPRISES, INC., a domestic corporation which is not a member of any affiliated group.

## ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 1414 1st Street S.W., Ruskin, FL 33570.

## ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of asphalt paving and any other related construction activity;
